

CDHA is Recruiting!

RE: Standing Offer of Agreement (SOA) Sioux Lookout Zone Dental Hygienist Services for First Nations and Inuit Health (FNIH) - Ontario Region of Health Canada.

The CDHA is recruiting up to **20 qualified dental hygienists** to work on a contract basis to provide dental hygiene treatment and preventive services under the Sioux Lookout Dental Hygiene Program, operated by the First Nations and Inuit Health Branch (FNIHB) of Health Canada. Dental hygiene services will be provided to the residents in isolated communities in north western Ontario, and to those who can access the main dental clinic facility in Sioux Lookout. **The contract runs between September 2012 and September 2013.**

You will be employed in 4 week rotations consisting of 5 days per week (Monday to Friday), approximately 8 hours per day. You will be expected to remain in Sioux Lookout Zone for the full rotation period. Following your first work term, you will be rotated back into the community every 2 or 3 months depending on your availability and the workload requested by the Sioux Lookout Zone Project Authority.

You will be provided with meals (remote communities only) and accommodation during your work rotation. CDHA will schedule and pay for your flight to and from Sioux Lookout. Travel will be arranged from the departure cities of Toronto, Montreal, Ottawa, Winnipeg and Thunder Bay. It is your responsibility to arrange your travel to and from these departure cities, including costs for parking, taxis, etc.

Specific Criteria Required: You must

1. Be a licensed dental hygienist authorized to self-initiate in the province of Ontario for the duration of the contract. <http://www.cdho.org/Reference/English/StandardsSelfInitiation.pdf>
2. Provide evidence of Professional Liability Insurance
3. Have Public Works and Government of Canada Reliability Screening Status (details to follow for accepted applicants)
4. Be a CDHA member in good standing for the 2011-2012 and 2012-2013 membership years.
5. Have current/valid CPR certification

Additional Considerations

1. You must have flexibility to work every 2nd or 3rd month
3. Be mentally prepared to face isolation, different cultures and heavy workloads.

Remuneration

1. You will be compensated on a per diem rate of \$360.00 per day
2. As an independent contractor, you will be responsible for submitting payments for E.I., Canada Pension Plan, Ontario Health Insurance Program, Provincial and Federal taxes, HST (if applicable), to the appropriate offices.
3. You will not be paid for statutory holidays or receive any employee benefits from CDHA.
4. You will be provided with accommodation. Meals are provided in the remote postings only. CDHA will not pay for additional fees such as cellular telephone.

- Details of specific skills, languages etc. that uniquely qualify you for this position.
